# Dairy Cattle Evaluation

Nebraska Career Development Event Handbook and Rules for 2025-2029

### **1. PURPOSE**

a. The purpose of the Dairy Evaluation CDE is to provide a competitive event for agricultural education students which emphasizes skills in dairy cattle management and evaluation.

# 2. OBJECTIVES

- a. Team Activity:
  - Each team of 4 students will have up to 10 minutes to present their solution to a management problem to a panel of judges. The team will be given the role of consultants to solve the management problem, and they will then present their solution to the judges. The management problem topic will be determined based on the topic for the National FFA Dairy Evaluation contest to be held that year. Following the presentation, the panel of judges will have up to 5 minutes to ask questions to the team.
  - 2. Through the team activity, students will develop the following:
    - i. Organizational skills.
    - ii. Problem solving skills.
    - iii. Oral presentation skills.
    - iv. The ability to work as a team.
    - v. The ability to process information and answer questions.
- b. Written Test:
  - 1. Students will answer multiple choice questions covering the following, dairy cattle nutrition, anatomy, reproduction, breed characteristics and identification, diseases and disorders associated with dairy cattle and common management practices and facilities.
  - 2. Students will select animals based on individual analysis of a <u>dairy herd record</u> <u>analysis chart.</u>
- c. Evaluation:
  - 1. The contestant will evaluate and rank six classes of four dairy animals independently. These classes could be made of calves, replacement heifers and/or dry or producing cows of varying breeds.
- d. Oral Reasons:
  - 1. Contestant will:
    - i. Develop and deliver three sets of oral reasons. Oral reason classes will be announced before the judging starts. Using notes during the presentation is discouraged.
    - ii. Students will speak using strategies that ensure clarity, logic, purpose, professionalism, and correct dairy cattle industry terminology in their oral reasons.
    - iii. Produce clear and reasoned oral communication by writing and presenting oral reasons. (SEE APPENDIX 1 for Rubric.)

#### **3. ELIGIBILITY**

a. Any agricultural education students enrolled in an agricultural education class may compete in this CDE. As this event occurs at the Nebraska State Fair in August,

agricultural education students who graduated the previous spring are eligible to compete.

- b. A graduating senior is considered eligible to compete in state CDEs up to and including his or her first national convention following graduation.
- c. Students who have competed in a previous National Dairy Evaluation CDE are not eligible to participate in the Nebraska Dairy Evaluation CDE.
- d. Each school may enter one team of 4 contestants who will compete in all areas of the Dairy Evaluation CDE.
- e. Each school may also enter up to 4 additional contestants who will complete the individual components of the contest and will be eligible for individual awards only.
- f. As this contest is held in conjunction with the State 4-H Dairy Judging contest, eligible students may participate in both contests as long as they meet entry requirements
- g. To ensure that students participating in both the FFA and 4-H portion of the contest are eligible, any potential alternates to the FFA teams must be listed at the time of registration.
- h. Registration fees for the contest are \$5 per individual.

#### **4. REQUIRED ATTIRE**

- a. For the placing and oral reasons portion of the contest, contestants are required to wear the current State Fair t-shirt which will be provided to the contestants. Contestants competing in both FFA and 4-H portions of the contest may wear either the FFA or 4-H State Fair t-shirt. (Official FFA dress is not appropriate attire for this CDE.)
  - 1. For the team portion of the contest, teams may wear their State Fair FFA t-shirts, Official FFA Dress, Chapter FFA t-shirts or polos, or other appropriate attire.

#### **5. REQUIRED SUPPLIES AND EQUIPMENT**

- a. Each contestant should have a writing instrument and notebook for note taking during the contest.
- b. Laptop to give the presentation with necessary adaptors OR bring a USB Drive with presentation on it.
- c. Computer (PowerPoint compatible) LCD projector with cables, screen, internet access, a table, and 1 podium will be provided.
- d. Absolutely NO electronic devices, including cell phones, electronic notebooks, readers, tablets, iPods, etc. may be used during the individual portion of this event.

#### 6. EVENT SCHEDULE

- a. Entries are due to the contest superintendent by August 10 (State Fair Requirement.)
- b. Team scenarios will be emailed to registered teams between August 11-15th.
- c. The contest will take place during the weekend of the Dairy Cattle show of the Nebraska State Fair in conjunction with the State 4-H Dairy Evaluation contest.
  - 1. 8:00 a.m. 11:00 a.m. Team presentations and individual written exams; exact time to be designated for each school.
  - 2. 12-12:15 p.m. Judging Contest Registration
  - 3. 12:15-12:30 p.m. Judging Orientation
  - 4. 12:30-2 p.m. Judging of classes; contestants will be given 12 15 minutes to judge each class
  - 5. 2-2:15 p.m. Break (<u>Contestants will move to a different location to give oral</u> <u>reasons.</u>)
  - 6. 2:15-4 p.m. Oral Reasons Given; contestants will be given at least 15 minutes between sets of reasons to prepare their next set of reasons
  - 7. 5:00-6:30 p.m. Dairy Contest Awards Ceremony

# 7. ANNUAL THEME

- a. The team presentation will be based on a topic similar to the National FFA Dairy Evaluation topic for that year. Topics known at this time are, the one chosen will match National FFA for that year:
  - 1. Genetics/Reproduction
  - 2. Housing/Facilities
  - 3. Health/Diseases
  - 4. Young Stock Management
  - 5. Feeds/Nutrition

### 8. EVENT FORMAT

- a. The management test will contain 50 questions 40 industry related questions and 10 questions using a dairy herd record evaluation sheet to evaluate individual cows (similar to the team problem from contests prior to 2012).
  - 1. Modern Livestock and Poultry Production textbook. Chapters 3, 4, 5, 6, 9, 10, and 39 - 46.
  - 2. National Agricultural Statistics Service Dairy Cattle facts.
  - 3. Dairy Cow Unified Scorecard
- b. Each contestant will place six classes of dairy cattle.

- 1. Every effort will be made to select classes of different breeds. Selection is based on cattle availability.
- 2. Resource Hoard's Dairyman Magazine.
- c. Each contestant will give three sets or oral reasons.
  - 1. Each team will be provided a dairy farm management scenario to identify problems and determine possible improvements. Teams should assume the role of a hired consultant advising a producer (judges). Teams will have 10 minutes to complete their presentation, with an additional five minutes allowed for questions from the judges.

#### 9. SCORING

- a. Each question of the management test will be worth 2 points, for a total of 100 points possible.
- b. Each class of cattle Is worth 50 points, for a total of 300 points possible.
- c. Each set of oral reasons is worth 50 points, for a total of 150 points possible (SEE APPENDIX 1 for Rubric.)
- d. The team presentation is worth 200 points. The team presentation will be scored using the rubric (SEE APPENDIX 2).

## **10. TIEBREAKER**

- e. If needed, the following tiebreakers will be used in the order listed:
  - 1. Total reasons score
  - 2. Lower placing score on reasons classes
  - 3. Written test score
  - 4. Total placing score
  - 5. Team ties will be broken using the same criteria as stated above, using the team totals in each area.

a. A copy of the exam will be emailed to all participating chapters following the completion of the contest. Others wishing to obtain past exams need to contact the event superintendent.

#### **13. POST-CDE DEBRIEFING OPPORTUNITY**

- a. Official placings of the classes will be shared following the completion of the contest.
- b. Copies of the judges' critique sheets will be sent to the participating schools as soon as possible after the contest.
- c. A list of class providers and sponsors will be shared with the participating schools, for the purpose of writing thank you notes.

# Appendix 1: Oral Reasons Scoring Guidelines

45-50 points	Completely accurate, correct organization, excellent delivery.
40-44 points	Mostly accurate, correct organization, adequate delivery.
30-39 points	Inaccurate in places, improper organization in spots, need more specific detail, average delivery.
20-29 points	Completely inaccurate, prioritization unclear, marginal detail, poor delivery.
<20 points	Minimal effort, did not appear to care or be involved in the event.
